ELEMENTARY BASKETBALL PROGRAM

Registration is for boys and girls - 2nd through 5th grade. This program will focus on learning the basic skills of dribbling, passing, and shooting; and the basics of team offense and defense. The program will begin on Saturday, November 17th and continue each Saturday through December 22nd. Times for each age group are: 2nd- 3rd grade 9 to 10:30 a.m. /4th-5th grade 10:30 a.m.-12:00 p.m. After the Saturday practices/games are done, the participants will play during the half-time of high school basketball home games in January and February(schedule of those games will be handed out November Dec.9th). In order to continue to practice what they've learned, the Park District gym can be used for **free** on Wednesday nights in January, **if the child wears their program basketball shirt**. The number of participants will determine whether we will have co-ed or boy/girl teams. Please have child wear tennis shoes and comfortable shorts/pants and t-shirt.

The cost is \$20 per child (\$15 with Park District Membership) with a \$50 maximum per family (\$40 with membership), fee includes t-shirt. Please make checks payable to the Prophetstown Park District and submit fee with this completed registration form (one per child) to the Prophetstown Park District or school office. If fee is not present, form cannot be accepted. You can sign up the first day of the program, November 18th, for an additional \$5.00 late fee.

IMPORTANT INFORMATION

Depending on the particular activity, participants must understand that certain risks, dangers and injuries due to inclement weather, slipping, falling, poor skill level or conditioning, carelessness, horseplay, unsportsmanlike conduct, premises defects, inadequate or defective equipment, inadequate supervision, instruction or officiating, and all other circumstances inherent to indoor and outdoor recreational activities/programs exist. In this regard, it must be recognized that it is impossible for the Prophetstown Park District to guarantee absolute safety.

WAIVER AND RELEASE OF ALL CLAIMS

Please read this form carefully and be aware that in signing up and participating in the above identified programs/activities, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damage or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with said programs/activities (including transportation services/vehicle operation, when provided). I recognize and acknowledge that there are certain risks of physical injury to participants in these programs/activities, and I voluntarily agree to assume the full risk of all injuries, damages or loss, regardless of severity, which I or my minor child/ward may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in these programs/activities against the Prophetstown Park District, including its officials, agents, volunteers and employees (hereinafter collectively referred as "Prophetstown Park District"). I do hereby fully release and forever discharge the Prophetstown Park District from any and all claims from injuries, damage or loss which I or my minor child/ward may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with these programs/activities.
